Porshia Garcia Deputy Director, Development Services Department City of Fort Lauderdale

Mrs. Porshia Garcia, MPA, is an executive public administrator and proud United States Army veteran. As a paralegal specialist in the Judge Advocate General's Corps (JAG), Porshia provided legal support internationally and domestically to attorneys and battalion command staff from 2008 to 2014.

In March of 2014, Porshia began her career in public service as an administrative aide in the City of Fort Lauderdale's Community Enhancement and Compliance

Division. Porshia's hard work, passion for public service, relationship fostering, and solutions-driven approach has earned her much success as a public administrator. In 2016, she was promoted to administrative services supervisor for Community Enhancement and in 2017, Porshia became the division manager for Community Enhancement. Porshia's ability to develop and implement a strategic code enforcement program, rally other departments and external agencies for neighborhood enhancement projects, and foster a positive work culture within her division have earned her a reputation for excellence and made her a go-to for many organizations seeking advice on their code enforcement programs.

Russell McCaffery Dean of the Industry, Manufacturing, Construction, and Transportation pathway Broward College

Russell N. McCaffery is the Dean of the Industry, Manufacturing, Construction, and Transportation pathway at Broward College. In this role he oversees 2,000 students in the college's Aviation, Supply Chain Management, Automotive, Marine, Building Construction, and Manufacturing programs. He has worked in transportation-related positions for well over 25 years. He secured a \$24.5M Department of Labor grant, the largest single grant in Broward College history, to develop industry certifications for

entry-level positions in the supply chain management field in partnership with the Council of Supply Chain Management Professionals. Broward College currently manages the program on behalf of CSCMP.
